**TERMS AND CONDITIONS FOR ALL ANIMALS BOARDED AT KLASSIC KENNELS:
PLEASE READ AND INITIAL ALL ITEMS**

_____ You are responsible for payment of all boarding and grooming fees and any additional costs incurred by the Kennel, including authorized veterinary costs, at the time the animal is released. If you do not pick up the animal within five days of the day agreed upon, the Kennel may assume the animal is abandoned and you authorize us to dispose or rehome of the animal as we see fit.

_____ The Kennel will exercise reasonable care in boarding your animal. You agree to hold the Kennel free of all responsibility and/or liability for illness, injury, or death of your animal in the absence of gross negligence. You agree that the kennel's liability shall in no event exceed the current market value of a pet of similar breed or pedigree.

_____ You agree to be solely responsible for any and all acts or behavior of your animal while it is in the care of the Kennel. You agree that you have disclosed any and all medical or behaviour related issues your pet may have. You understand and agree that in admitting your animal(s) is/are in good health and have not harmed or shown aggressive or threatening behaviour towards any person or any other animal, you do understand that all cost in connection with veterinary, medical or treatment, shall be your responsibility.

_____ If your animal becomes ill or is injured while being boarded, the Kennel will take any immediate emergency action necessary for its well-being. If it is necessary to seek veterinary care for your animal, we will attempt to contact you. If you are unreachable, you agree to:
